### Student Driver Form

\*\*\*Any student who wishes to drive to school must complete this form and purchase a parking permit (\$25 per spot). Student driving is considered a privilege. Failure to follow the policies outlined below may result in the loss of this privilege.

### Student Driving Guidelines

1. Students may only park in their **assigned parking spot**.
2. **Parking permits must be displayed** on the rearview mirror, facing forward, at all times while on campus.
3. Student drivers must be **at least 16 years old** and possess a **valid North Carolina driver's license**.
4. Students transporting other students (except siblings) must have **parental permission** from all parties involved.
5. Students may not loiter, congregate, or remain in vehicles during the school day.
6. Students may not return to their vehicle during school hours **without staff or teacher permission**.
7. Safe and respectful driving must be practiced at all times.
8. Reckless driving, riding on the outside of vehicles, or riding in the bed of a pickup truck is **strictly prohibited** and may result in disciplinary action, including suspension.
9. Students may not drive another student's vehicle **without written consent** from both sets of parents and the vehicle owner.
10. **Six (6) unexcused tardies** in a single quarter may result in suspension of driving privileges for the following quarter.
11. Vehicles are subject to **search by school administration** if there is reasonable suspicion of prohibited items.
12. Violation of any of the above may result in **loss of parking/driving privileges**.
